Each winter, 25 Costa Rican high school students, who have been carefully and competitively selected to represent their communities and their country, come to Oregon to live with host families and **attend school with their host brothers/sisters. The student attends school, but does not enroll** for the purpose of transferring credits. Instead, the **student audits classes** and is expected to be a resource for schools by sharing information about Costa Rica and enhancing the Spanish language classes as a native speaker.

Costa Rican students on the Partners program travel with valid passports and visas, health insurance, and are accompanied by two English-speaking chaperones who remain in Oregon for the duration of the 8-week program. The Oregon Partners of the Americas High School Exchange Committee and the Costa Rican chaperones work together to ensure that families, schools and students have a mutually beneficial experience.

Students on the Partners program are expected to be exemplary representatives of Costa Rica. As such, students are closely monitored by their chaperones and the Oregon Partners High School Exchange Committee. Partners guarantees the financial support of all program participants during their stay in Oregon, as well as their return air fare at the completion of the program. Each student is prepared to comply with State of Oregon Health Department immunization requirements.

Who are we?

Partners of the Americas is the western hemisphere's largest, private **volunteer** organization engaged in economic and social development and technical training, while fostering inter-American friendship and cooperation.

Partners was founded in 1964 as the "people-to-people" component of the John F. Kennedy Administration's Alliance for Progress.
